

Information pursuant to art. 13 of the European Regulation n. 679/2016 and in accordance with the national legislation on the protection of personal data

Pursuant to art. 13 of the European Regulation on the protection of personal data (hereinafter also GDPR), Italdesign-Giugiaro S.p.A., as Data Controller pursuant to art. 24 GDPR, communicates the following information:

A) Data Controller and Data Protection Officer

The Data Controller is Italdesign-Giugiaro S.p.A., with registered office in Turin, Via San Quintino 28 and operational headquarters in Moncalieri (TO), via Achille Grandi 25, which can be contacted by writing to privacy@italdesign.it or by sending a registered letter to the attention of the Compliance Officer c/o Italdesign - Giugiaro S.p.A., via Achille Grandi 25, Moncalieri (TO).

The Data Protection Officer (DPO) can be contacted by sending an e-mail to dpo@italdesign.it.

B) Purpose of processing

The processing of your Personal Data is carried out within the scope of the activity of our Company for the following purposes:

- Preliminary checks in order to formulate offers and proposals;
- Fulfillment of pre-contractual, contractual and tax obligations;
- Management of the contractual relationship;
- Management of any disputes;
- Compliance with the obligations set forth by laws, regulations and community regulations, including accounting and tax;
- Fulfillment of instructions issued by entitled authorities and by judicial, supervisory and control bodies.

C) Processing methods

Personal data are processed by the Data Controller in compliance with the principles of lawfulness, correctness and transparency.

The processing of your personal data is carried out by means of the following operations: collection, registration, organization, structuring, storage, consultation, adaptation or modification, use, dissemination, communication, extraction, comparison, interconnection, limitation, deletion and destruction of data. Your personal data are processed by both paper and electronic means.

The Data Controller will process your personal data for the time necessary to fulfill the purposes highlighted under article B, and in any case no longer than 10 years from the end of the contractual relationship.

D) Type of Data processed

The provision of your personal data for the purposes highlighted under art. B. is optional, but their communication is strictly necessary in order to fulfill contractual and legal obligations. Any total or partial refusal to provide your personal data will preclude the establishment of a contractual relationship with you, due to the fact that the Data Controller will be unable to comply with the relevant legal and/or contractual obligations.

E) Subjects and categories of subjects to whom the data may be communicated

In addition to the Italdesign-Giugiaro S.p.A. staff, authorized to process your data, and to Data Processors, the abovementioned data may be disclosed to the following subjects:

- Other companies of the Italdesign-Giugiaro SpA group if necessary in the execution of the related activities;
- Client companies and / or business partner of the Data Controller;
- Consultants, collaborators, individuals, companies and professional firms - which the Company relies on (law firms, banking institutions, insurance companies, accountancy firms, auditing firms);
- Public or private subjects in accordance with the obligations provided for by law.

F) Rights of the Subject

In accordance with the articles 15 (Right of access), 16 (Right of rectification), 17 (Right to cancellation), 18 (Right to limitation of processing), 20 (Right to portability), 21 (Right to opposition), 22 (Right to Opposition to the automated process), 77 (Right to file a complaint to the Supervisory Authority) of the GDPR, the Subject can exercise his rights by writing to privacy@italdesign.it.
